4.1. Description of first aid measures

In the event of exposure by inhalation :

SECTION 5 : FIREFIGHTING MEASURES

Flammable.

Chemical powders, carbon dioxide and other extinguishing gas are suitable for small fires.

SECTION 6 : ACCIDENTAL RELEASE MEASURES

6.1. Personal precautions, protective equipment and emergency procedures

SECTION 7 : HANDLING AND STORAGE

Requirements relating to storage premises apply to all facilities where the mixture is handled.

7.1. Precautions for safe handling

Always wash hands after handling.

Ensure that there is adequate ventilation, especially in confined areas.

Prevent every contact with the skin and the eyes.

Prevent accumulation of electrostatic charges.

Pulverise by short pressions, without prolonged pulverisation.

Follow hygiene and security rules because flammable capacity.

Do not inhale steams.

Do not smoke.

Do not mix with anothers chemical products.

Where the personnel must carry out work in a booth, whether for spraying or otherwise, the ventilation may be inadequate to control particles and solvent vapors in every case.

It is therefore recommended that personnel wear masks with a compressed air supply during spraying operations until the concentration of particles and solvent vapors has fallen below the exposure limits.

Packages which have been opened must be reclosed carefully and stored in an upright position.
